

Enrollment Agreement between Serve and Thrive (S&T) and Student

Tuition includes course materials, use of equipment and supplies related to this training program. Tuition includes daily use fee for pools, spa, grounds of Mimpi, Menjangan. Tuition includes a training manual, 175 credit hours in Esalen Massage training. Tuition includes payment for instructors/instruction, support through your certification completion, and postgraduate support.

Fees:

Two Esalen® Massages at home site or in Bali: price in Bali is 60.00 USD per session.

Upon registration you are entering into a binding contractual agreement with the terms expressed on this page.

Your place in this program is reserved and secured with payment of a deposit. Required deposit may vary per program. The remaining balance for **full tuition must be received no later than 60 days prior to the first day of the course**. If you register within 60 days of the start of the course, the entire fee is due upon registration and no refunds will be available. See refund and cancellation policy below.

Payments are to be made through our website. If you are unable to pay online, Contact us for other options to pay by Paypal, Venmo, Wise, and Wire Transfer from your bank to ours.. Note that any additional fees for Paypal or Wire Transfers will be paid for by the client. This is commonly \$25 USD per wire transfer for MV to receive your payment. Fees vary for PayPal and Wise.

Participant Cancellation & Refund Policy: Cancellation of participation in workshops & events is possible up to 60 days prior to the first day of the course. Up to and until this date, all money paid, less the non-refundable deposit paid, will be refunded to the applicant by MV. Applicants who, for any reason (including illness, death in the family, accidents, professional obligations, etc.) find themselves unable to participate in the course and have not canceled 60 days prior to the start of the event, are ineligible for a refund. All fees are due in full 60 days prior to the start date of the program. Contact your travel insurance company for any coverage for air travel fees, and any deposit recovery for this program.

If you wish to cancel your reservation on a retreat or event you must notify Serve & Thrive in writing.

Once we've received your notice, cancellation will take effect subject to the following:

- If cancellation takes place more than 60 days prior to your departure date any payments made minus your deposit will be refunded.
- If cancellation takes place less than 60 days prior to your departure date, 100% of the retreat price will be forfeited and/or you will be required to make final payment for the event. Note that some events do not accept cancellations.

This is clearly posted on the workshop information page.

Travel insurance is required to cover unexpected medical events, lost luggage, delayed or canceled flights, and the need to cancel a trip.

Note that your Travel Insurance may protect you against event cancellation.

S&T will consider offering a reduction to a future program of ½ of the amount paid. If a replacement participant is found for your place in the program, we will refund 70% of your payment.

S&T agrees that in such cases, the applicant may find a suitable replacement to take his/her place in this training, providing an application is filled out, and an enrollment agreement is signed by the replacement. Creating these programs requires that we know in advance the number of participants to share with venues, teachers, transportation and other such providers for thorough preparation in a timely manner.

Deposit:

Deposit payments are non-refundable, with the exception of the event that Serve and Thrive cancels a program. If Serve & Thrive reschedules a program you will have the option to use this towards the training at the re-scheduled time or have the deposit returned to you. The deposit for the Esalen Massage Teacher Training is 1,000.00 per module. The deposit for the Esalen Massage Certification is 1,000.00. Serve and Thrive Event and/or Participant Cancellation Policy: Serve & Thrive retains the sole right to revoke the participation in this training of any individual participant, at its discretion.

S&T also retains the right to cancel an event up to 30 days prior to the first day of the course, should for any reason this become a necessity or if a workshop does not meet the minimum number of participants. In such a case, all money received by S&T from applicants shall be promptly refunded - including deposits.

S&T and any persons associated with S&T or employed by Serve & Thrive shall not be liable for any expenses incurred by applicants in preparing for this training, including travel expenses, telephone and mail expenses.

Shared Room Policy

Choosing the shared room option for the program require you to do the following:

- In the event we are unable to find you a roommate, you will have to opt for a private room
- In case you want to switch from shared room to a private room during the program, you will be charge the amount of the remaining nights as a cancellation fee for leaving the shared room. You will be charged for the remaining nights at the private room rate.

Serve & Thrive's Cancellation and Refund Policy:

Refunds have the following stipulations: If you withdraw from the course or are dismissed after instruction has begun, you will receive a pro rata refund for the unused portion of the tuition, effective the date of your withdrawal notice, **if you have completed 25% or less of the instruction. No refunds are available for tuition after completing 25% of the training.**

Room and board refunds are prorated on a room and board basis, with consideration of any roommate left without a roommate, less the required organizers' non-refundable deposit.

After you complete 25% of the training, no tuition refund is available.

It is not in our interest to cancel an event, we must however secure a minimum of 10 students for a program to go ahead. We always aim to reschedule a program, and rarely do we cancel an event. Insurance Serve & Thrive requires the purchase of travel insurance. **It is your responsibility to ensure that you are adequately insured for the full duration of the retreat or event in respect of illness, injury, death, loss of baggage and personal items and cancellation and curtailment**

By participating in our programs you are aware that participation in our training can involve various risks. Physical movement (dancing, yoga, walking, running in or outside of the facility where this training takes place), meditation, and massage can result in serious physical injury and/or loss of

emotional and mental orientation/stability. By registering in this program you take full responsibility for your participation in this training, and will not hold Serve & Thrive , or any person associated with Serve & Thrive liable for anything that may occur as a result of participation in this training.
